# Abbotsford Juniors Football Club (AJFC) Minutes from the Annual General Meeting 2022

## 1. Welcome and Introduction (President)

The meeting was opened by Chris Williamson (President) welcoming all members and confirming that a quorum of AJFC Members was present at the meeting.
2. Minutes of the 2021 Annual General Meeting

3. Review of Income \& Expenditure during 2022 (Treasurer)

Paul Simeoni (Treasurer) tabled the Club Financial report including the reports of the Directors and Auditors for the financial year up to 30 September 2022. The Treasurer reported that the Club was a good balance sheet position and delivered a small surplus of $\$ 37 \mathrm{~K}$ for the financial year

The Treasurer advised that the 2023 financial year would be a challenging year as a result of the increased expenditure of approx. \$130k upfront costs for the Club's new jerseys. There will be additional costs for shorts and socks - which will be absorbed at the time of ordering as required. With the 2023 budget forecasting a loss, with a better return expected for FY2024/25, the focus will be to try to minimise capital expenditure during 2023 - whilst at the same commencing the work to create an AJFC Master Plan to activate the Club precinct.

The President advised that the club is actively looking at ways to increase revenues from other sources - including sponsorship, 2 holiday camps and investigating opportunities to participate in various grant schemes.

Confirm that the Club Financial Report and the report of the Directors and Auditors for the financial year ended 30 September 2022 be accepted.

Proposed by Nicholas Ancona and seconded by Chris Williamson. Accepted Unanimously.
